

TERMS & CONDITIONS

PROVISIONAL BOOKING

We can accept provisional bookings, but they will only be held for 7 days, during which time we must receive a signed booking form and a deposit of £5 per person to confirm your booking.

BOOKING FORM & DEPOSIT

To secure a booking, each party event requires a party booking form to be completed and signed plus a deposit paid of £5 per person. This may be paid in cash or credit/debit card. The balance must be paid in full by 30th November 2019. Bookings made after this date must be paid in full im-mediately.

CANCELLATION

Notification of cancellation is required in writing 30 days prior to the event to receive a full refund of monies paid. For cancellations made less than 30 days prior to the event, the deposit payment will be forfeited. Once the balance has been paid in full, if you cancel you will forfeit both the deposit and balance.

MINIMUM GROUP SIZES & NO-SHOWS
